Due to limited space availability, you are encouraged to secure your space as soon as possible. A space is only reserved upon payment of fees and completion of required application, and all paperwork. All Vendor booths will be assigned on a first come basis and all assignments will be confirmed via email. All fees are non – refundable.

Each Vendor space will be provided with **one canopy booth (10' x 10')**. **An 8ft table and two (2) chairs.** **NO ELECTRICITY WILL BE AVAILABLE.**

A SELLER'S PERMIT FOR ALL VENDORS SELLING ANYTHING. If you are a vendor that will be selling anything then you must have a seller's permit.

If you need a permit, then you can get a free TEMPORARY SELLER'S PERMIT on-line from the State Board of Equalization. <http://www.boe.ca.gov/> On the California Seller's Permit Application the Event's address for the temporary permit is 400 N. Harbor Blvd., Anaheim, CA 92805

ALL FOOD VENDORS will also need forms from the Food Vendor TFF Application Packet – the **HEALTH PERMIT APPLICATION** (TFF page 3), and both pages of the **OPERATION SPECIFICATIONS** (TFF pages 5-6).

ALL COOKING FOOD VENDORS MUST BRING THEIR OWN FIRE EXTINGUISHER! NO EXCEPTIONS!

NON-PROFIT FOOD VENDOR your 501 (c)(3) Tax Exempt Status for your organization must be current. You will need proof of status that meets Health Department requirements.

PROOF OF NON-PROFIT STATUS IS ONLY REQUIRED FOR THE FOOD VENDORS

FOOD VENDORS ALL REQUIRED PAPERWORK MUST BE SUBMITTED WITH APPLICATION
Please return all the required documents with your application and fee to the Orange County Heritage Council by the deadline due date and NOT to the County of Orange Health Care Agency.

The Vendor space is only reserved and confirmed once application and fees have been received.
